

## EVENT ATTENDEE WAIVER AND RELEASE OF LIABILITY FORM

Avaya and the International Avaya User Group (IAUG) continue to monitor federal, state and local regulatory requirements and Centers for Disease Control and Prevention (CDC) guidelines regarding COVID-related restrictions and requirements. - If I have traveled internationally during the last 14 days, I have complied with all applicable COVID-19 related travels restrictions, laws, and regulations.

By signing this Event Attendee Waiver and Release of Liability Form, I acknowledge the contagious and evolving nature of COVID-19 and voluntarily assume the risk that I may be exposed to the virus and become infected as a result.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any expense, liability, illness, injury, disability, or death related to contracting the virus while attending Avaya ENGAGE 2021. I hereby release, covenant not to sue, discharge, and hold harmless Avaya and IAUG from all claims of any kind arising out of exposure or contracting of COVID-19. I understand and agree that release of liability includes any claims towards Avaya, Avaya employees, Avaya representatives, IAUG, and IAUG staff whether a COVID-19 infection occurrence exists before, during, or after attendance and participation at Avaya ENGAGE 2021.
